Proposed Bylaw Revisions

The Bylaws Committee will hold a voting session at the November General Meeting concerning proposed isolated changes to the association's bylaws. A copy of these proposed changes, as well as a copy of the existing bylaws is available on our website, via email, regular mail, and at our General Meeting. Moreover, the Bylaws Committee will formally present these proposed changes at the October and November General Meetings.

The substance of the current proposed changes is to: 1) include specific verbiage regarding the transparency of the neighborhood association, 2) allow the neighborhood association to conduct business as the "South Baltimore Neighborhood Association", and 3) strike the requirement that the association must maintain a Committee dedicated to RPP (Residential Permitted Parking).

Please show up early, at 6:30 pm, to enjoy complimentary food and drinks, and to socialize with the Executive Board and your neighbors about what is happening in the neighborhood.

Proposed Substantive Amendments to SBIC Bylaws

The following are the proposed amendments to the Organization's bylaws. These amendments will be formally presented and discussed at the September General Membership meeting, and voted on at the October General Membership meeting. For the full text of the existing bylaws, please visit www.soboimco.org/resources/SBIC_Bylaws.pdf.

Article II

Change current Section 4 to Section 5.

Add Section 4:

The SBIC will seek to keep all residents of South Baltimore informed of neighborhood plans, developments, and initiatives in an open and timely manner. The SBIC shall disseminate neighborhood information through appropriate means of communication, excepting that information which is of a legal or sensitive nature.

Article IV

Change current Sections 4 and 5 to Sections 5 and 6, respectively.

Add Section 4:

Executive Board members will present all relevant information to residents, listen to resident responses and petitions, and adhere to all decisions reached via voting or informal consensus in accordance with organizational bylaw s and other regulatory agencies. Meeting agendas will include sufficient time for residents to ask questions and voice concerns.

Article V

Insert new Section 3:

The Officers are responsible for maintaining and ensuring the integrity and timeliness of communication with residents.

Article VI

Change Section 4 to Section 7.

Add Section 4:

Executive Board meetings shall be open to residents who request attendance. The meeting schedules, tentative locations, and draft agendas shall be

made available via appropriate means of communication. In cases involving legal or sensitive matters, the Executive Board may, by a majority vote, declare a closed Executive Session to handle that matter only. Once the matter is resolved, its status shall be made available via appropriate means of communication.

Add Section 5:

The Executive Board shall disseminate a complete and timely summary of its actions via appropriate means of communication.

Add Section 6:

All Executive Board members are responsible for maintaining and ensuring the integrity and timeliness of communication with residents.

Article VII

Section 2, after third sentence ("Chairs of the standing committees shall recruit committee members to assist in researching and developing solutions to issues."), add:

Standing Committee participation is open to all association members. Individuals who are disruptive or who constitute a conflict of interest may be removed or excluded only by a majority vote of the committee membership. Such removal or exclusion must be reported to the Executive Board.

Article VIII

Section 3, after first sentence ("Chairs of the ad-hoc committees shall recruit committee members to assist in researching and developing solutions to these issues."), add:

Ad Hoc Committee participation is open to all association members. Individuals who are disruptive or constitute a conflict of interest may be removed or excluded only by a majority vote of the Ad Hoc committee membership. Such removal or exclusion must be reported to the Executive Board.


AREAS 9,19, 30 – 2 Hour Only w/o Permit 7 AM-6 PM Mon-Sat, Sun 7 AM-2PM



And this year, for the first time, there will be a Silent Auction, highlighted by sports memorabilia, restaurant gift certificates, and real German antiques.


