MEETING MINUTES

GENERAL MEMBERSHIP MEETING

04/05/2011

1.Officer Butterbean began the meeting by reporting that auto larceny and all other crime categories are down from last year, due in part to the vigilance of residents. He can be reached at Kevin.vaught@baltimorepolice.org, 443-681-0920.

A discussion ensued regarding the recent Irish Stroll event. Members were pleased to see that the Fire Marshall was out enforcing occupancy codes by temporarily shutting down several establishments until the number of occupants was within code.

There was much dissatisfaction voiced that an event of such magnitude and with such potential adverse effects on the neighborhood could be allowed by the City without contingency plans or clear line of authority to shut it down if it became out of control. The Hospitality Association projected an attendance of 7500. Why shouldn't such an event be required to obtain a permit and provide security as do the regular summer street festivals?

It was suggested that we start now to organize a game plan for the next Halloween pub crawl event - perhaps work to have ticket sales limited.

It was agreed that we will send a letter of concern to the Liquor Board, our Councilman and our State Representative.

We were reminded that if we need any police assistance, call 911, not 311. We need to be ready to provide the address where a problem may exist. That address will then be logged in to start a history of occurrences.

2. Ross Albers, our area's Assistant State's Attorney, introduced himself. He lives in our area and will be getting more involved in all the neighborhoods in his jurisdiction. After listening to our pub crawl concerns, he suggested we combine forces with other nearby neighborhood associations that share our concerns. Teen Council Report - Marie Sennett

Marie again announced that she is looking for a new Council Chair or Co-Chair, as she will be stepping down in the near future. Please contact her to find out more about this rewarding opportunity.

Parking Committee Report - Debbie Alt

Debbie again stated that she is working toward getting Parking Area 30 under SBNA jurisdiction. Area 30 parking area is presently under the jurisdiction of the West Federal Hill Homeowners and Residents Association. SBNA does not have a parking area assigned to it and therefore does not have a vote at the Parking Authority.

A discussion took place regarding plans by The Reserve for valet parking. Members expressed concern that the valet reserved spaces would be taken from Area 30 spaces. It was explained by others that the valet spaces would be open parking spaces, not Area 30 permitted spaces and that it is in the residents' interest to park customer cars off the street at a valet lot.

Design Review

The SBNA Design Review board has received information for a proposed project at 127 W Fort Ave, located at the corner of Fort Avenue & Race Street. This project is divided into 5 lots within an R-8 Zone.

Variances are requested when the site conditions causes undue hardship that prevent zoning code from being applied. The applicant is applying for 3 variances:

Height: In an R-8 Zone, the maximum allowed height is 35'-0". The drawings currently show 43'-6" for 6 buildings.

Lot Occupancy: In an R-8 Zone, the maximum Lot Occupancy is 60%. This means that the total building footprint cannot exceed 60% of the total site square footage. 6 buildings currently show 100% Lot Occupancy. 4 buildings show approximately 68%.

Rear Yard: In an R-8 Zone, the building is not allowed to be located within 25'-0" of the rear property line. 6 buildings currently show no set back. While 4 buildings show a 20'-0" set back.

The neighbors of this site have been informed by both the SBNA as well as the developer and are, at the time of this printing, determining the best course of action.

UPDATE: E 20 Fort Avenue

The 10 building project between Fort Ave and Birckhead Street along Patapsco Street, which received a letter of approval from the SBNA, has sent an update. The project cleared the zoning board in February. The Developer has entered Permitting and has to make some adjustments to conform as part of the process and is nearing the end. The developer hopes to pass permitting within the next 60 days and will begin demolition once allowed by Baltimore City.

Design Review - Justin Wilde

Julie Tice presented the proposed project at 129 W. Fort Ave., at the corner of Fort and Race, currently a vacant lot. Project consists of 10 residential units. Julie is the project architect and owner's representative. Units will be 3 bedrooms, 2500 square feet, 3 stories on Race Street side, 4 stories on Fort Ave. side. One off street parking space will be provided for each unit. Membership in Area 30 is desired.

A bank owns the property and would like to sell the entire project as a whole, but may sell individual units.

The previous project approved for this site consisted of 8 residential units. Julie stated that the new proposed project has 10 units in order to be financially viable for the bank, which has \$2 million invested in it. Fitting 10 units on the property requires that 6 units be 4 stories in height. She stated that the project does not require a zoning variance.

The Board of Zoning Appeals hearing will be May 10, 2011. Signs will be posted on the property 4/29/11.

Concerns were expressed about impact on parking and a future detailed discussion with Julie will be scheduled.
