1901 South Charles Street Project HUD Status

Late in the summer, a new sign placement on the construction fence of 1901 S. Charles Street bounding the future 176,000 Square Foot complex stirred concern for many South Baltimore Residents. The US Housing & Urban Development (HUD) is now involved. Rumors quickly circulated that the advertised luxury apartments would now be low income or worse. How could such a drastic change happen?

The truth is it didn't. The project is still slated to be market rate driven luxury / moderate income housing . Unfortunately, many people hear the acronym "HUD" and think low income or section 8. To the contrary, US HUD is a massive department that reaches millions of Americans from all walks of life. It plays a vital role in maintaining the standards for the least fortunate of us so that safe and functional housing is available. It also helped more people than one would imagine acquire their homes thanks to tax credits and providing mortgage options. When I hear HUD, I think of the

FHA-backed mortgage used to purchase my home when credit all but dried up due to the economic down-turn.

For the 1901 South Charles Street Project, the major change that opened the door for HUD Funding occurred a few years back when the condominiums lost viability. The original project of 139 condominiums was originally purchased by Charles Development, LLC and then sold to Chesapeake Realty Partners with Clark Builders Group as the contractor. The project was then converted from the condominiums to its current configuration of 193 apartments. As a rental property, 1901 South Charles Street qualified for US HUD backing, which brought the project to life.

Due to the current national economic situation and the limited availability of deep financial backing, the appearance of US HUD logos may become a more common sight for other rental developments. For 1901 South Charles Street, the utilization of US HUD programs saved a major construction project that may change South Baltimore for the better.

in the spot that used to be Rub Restaurant and my husband, myself and our friend Roger ventured out to give it a try on opening night on 11/11/11. The décor has changed and they have certainly de-Texas-ed the place by removing all of the cowboy motif and replaced it with modern and hip décor. We were warmly greeted by the owner, Stephanie Hershkovitz and her mom and our party of 3 was seated promptly. Stephanie and her brother Josh are the brother/sister team that has founded Hersh's Pizza and according to the Sun paper, "What's local, what's fresh," says Josh. "It's the way we like to cook with the best ingredients."

Now lets get to the Pizza- the pizzas are fresh baked in a woodburning oven imported from Italy and they were delicious and affordable. I ordered the Margherita (\$10), husband ordered Kale & Pistachio (\$12) and Roger selected Prosciutto & Arugula (\$13). 



Electric Vehicle Charging Stations Installed in 9 Parking Authority Garages

Working with the City Energy Office, the Parking Authority of Baltimore City has installed electric vehicle (EV) charging stations in nine City owned parking garages. Each charging station is capable of charging two vehicles simultaneously, allowing

up to 18 electric vehicles to recharge their cars batteries.

This new program was made possible by a grant from the Maryland Energy Association.

Drivers of electric vehicles can park and charge their vehicles at one of the following PABC garages:

Arena Garage 99 S. Howard Street (2nd Level)
Baltimore Street Garage 15 Guilford Avenue (3rd Level)
Caroline Street Garage 805 S. Caroline Street (1st Level)
Little Italy Garage 400 S. Central Avenue (1st Level)
Penn Station Garage 1151 N. Charles Street (Level 1B)
Redwood Street Garage 11 S. Eutaw Street (Lower Level)
Water Street Garage 414 Water Street (Level 3)
West Street Garage 40 E. West Street (Lower Level)


