While we may not change the hours of operation for the casino, SBNA was assured we will have future opportunities to meet with the casino owners and city officials to disburse funds for additional security/policing in our neighborhood. We also may receive funding for community projects.

In closing I'll return to our theme and take liberties in modifying a famous quote from President JFK, "Ask not what SBNA can do for YOU rather ask what YOU can do for SBNA"

AN HISTORIC PICNIC ON FEDERAL HILL


Sunday, May 6 from 12noon-2pm

Committee Reports

Liquor Advisory Committee – Justin Wilde – Corks sold liquor license to Rowhouse. We need to invite bar owners to our meetings to discuss the bar and it's business. Deb mentioned Mad River is filthy and we need to engage the bars and the owners so we can get a better response from them.

Clean & Green – Thomasina – Spoke with Eric Deihl from Balto City – there are 3-4 tree pits dug- goal is to increase the # of trees in SOBO

Police and Community Relations – There is a new Major of the South Baltimore District – David Reitz – Maj. Reitz stresses the importance of community involvement and has an open door policy, he encourages citizens to contact him. Maj. Reitz reacted to our concern about the nuisance crime stating that they are beginning a new initiative to reach out to bar owners and the department has overtime money that they will use to more actively patrol the area and will issue more fines where they deem appropriate. SO, THE HOUSE NEXT DOOR IS UNDER CONSTRUCTION...

Having a significant construction project immediately adjacent to your home can be challenging and disruptive, especially if you are a house spouse, have young children, or work during the night. General Contractors tend to start work early in the morning so they can finish by early afternoon to avoid rush hour traffic in either direction, and maximize their daylight hours. This is also the time that the average worker is away. Demolition of an existing structure, excavating and creation of a buildings landscape are particularly difficult as they involve heavy equipment. Above grade construction is also challenging due to the noise from power tools and hammering. Aesthetically, construction sites somehow almost always cause excess dust to overflow, no matter how diligent the contractor's preventative measures.

The above is typically the extent of disruption one can expect from the average construction site. A General Contractor, by law, cannot perform any work on your property. They are legally responsible for any damage that they inflict, either intentionally or unintentionally to your property, or the public area's around their site. All contractors also have to abide by the terms and conditions listed on their building permits. Building Permits only allow construction between specific times and only within the work week. Contractors are not allowed to work on the weekend or holidays unless they have a special exemption which is filed for on a per case basis. Not abiding to agency criteria or approved plans can result in heavy fines, and even a stop work order from Building Inspectors.

The contractor is directly responsible for limiting the extent of construction to within the property lines of his own project. He is not allowed to put a foot on a neighbors property unless given written or verbal consent. The contractor will shore within the hole that he digs for any subsurface work within his property line. This is a very important preventative measure that the contractor does to prevent surrounding buildings from being damaged due to grade shift, or undermining. The contractor will also put silt fences

around the perimeter of his property, to help minimize the amount of dirt that blows away, and storm drain filters, to prevent flooding due to debris clogging the storm drains. If the project site is large enough, they will even establish a designated construction entrance, which will be the only area that heavy vehicles will enter and leave the site.

An additional level of concern exists for row home owners as most older buildings have a shared party wall. Because one wall is used to support two buildings, a home can suffer the direct results of a neighboring project. A recommended course of action is to photo document the party wall from the basement to the attic as well as the exterior and roof, only if it can be safely accessed, at a high resolution with the time stamp on. This way, if any cracks form as a result of work being performed, you have proof that it was not there prior to the construction.

Many often feel the need to consult lawyers or engineers to preemptively examine their home. This is generally premature and expensive. Some also feel the need to repair their own homes or perform protective work. Having pre-emptive repairs performed to your own building may actually undermine your case if something does happen as the contractor could easily argue that the work you performed was not up to standard and resulted in the damage.

Another essential is to maintain proper communication with the site superintendent and the owner, if possible. Contractors will try to maintain positive relationships with adjoining neighbors. An angry neighbor is a potential liability as they can easily call city building inspectors (311), file complaints, and generally increase the costs and difficulty of their job. Also, owners may like having an extra pair of eyes on their construction project as they are a large investment of capital. What you learn about the contractors performance is also a great litmus test to determine whether you could use them for your own future project as a good contractor is hard to find.

NO TRUCK OVER 3/4 TONS by Melanie A. Ambridge

No that's not another earthquake that's just a heavy truck driving trough our neighborhood. I am sure the rumbling of the heavy trucks on our streets is a concerned to many of you - it should be. I started sending emails voicing my concern last summer. I finally got this in front of the right person and got a response. One of my biggest questions was why wasn't any one enforcing these violations.

I would like to share a letter I sent to the Baltimore City DOT and their response to my letter.

"As many of you already know there are signs all over the Federal Hill/South Baltimore neighborhood that read, "No Truck over 3/4 tons." These signs are blatantly ignored and never enforced. I am fed up with the damage the big trucks have done to our streets, our homes and hearing them!! I see the bulk of them going from Hanover to Ostend and Ostend to Hanover. I am not sure why these signs are ignored by truckers and not enforced by the police but I want to make it my goal to stop this from happening. The attached photo was taken this morning at approx 8:15am. This is just one of many. I have spoken to many neighbors that have the same feelings I do about this. Now that I have your contact information I will let them know how to contact you. I will also ask them to send photos of this very same thing. In fact all you have to do is come to our neighborhood and you'll see these truck all day long (and all night and in the middle of the night while everyone is trying to sleep)

These streets were not made for this amount of truck traffic. Better yet, our homes were not made to withstand this traffic. Hence

the reason many of us have had to make repairs to homes!

These trucks illegally use South Hanover as an alternate route between 95 and the city. There are street signs on every block that state NO TRUCKS OVER $\frac{3}{4}$ TONS. The trucks ignore these signs and use South Hanover all hours of the day and night. I have NEVER seen these long haul, 18-wheelers and various big rigs receive tickets for their infractions. Disregard of our traffic laws is allowing these drivers to destroy Baltimore.

South Hanover Street has suffered great wear and tear because of their presence. The weight of these trucks creates potholes and fractures in the street. Vibrations from their illegal transit cause the brick mortar on the fascades of our homes to eroded. The costs of these repairs are funded from the pockets of tax paying neighborhood homeowners. By continuing to let tractor-trailers use South Hanover Street we are allowing them to destroy the charm of Charm City.

These existing traffic laws need to be enforced in order to preserve the historic appeal of Baltimore, generate revenue for the city, and lessen the repair burden of home ownership on our tax paying citizens. Thank you in advance for your prompt attention to this matter."

The following is the last response I received from Valorie LaCour, City Planner III, City of Baltimore, Department of Transportation and the response I received from the Director of the BCDOT Khalil Zaied:



"Outreach to truck drivers and major employers in Baltimore City has started. BCDOT expects to implement the new truck routes during 2012.

- Legislation has been introduced in the Maryland General assembly 2012 session.
- · The legislation will enable Baltimore City to enforce truck routing using technology resources to cite drivers unwilling to comply with the City-wide truck routes.
- BCDOT is testing virtual enforcement technologies to allow the BCDOT to enforce routing restrictions.

Regarding Hanover Street, BCDOT is reviewing all complaints and looking at strategies for enforcing routing along this corridor. Hanover Street is one of the corridors BCDOT is testing the virtual enforcement technology. In the interim, BCDOT will identify and contact companies and employers to inform them of the restrictions on Hano-

ver Street and work to get these companies to comply with the routing and restrictions."

Here is the response from the Director:

"Ms. Ambridge, truck enforcement is very difficult and at this time is not the responsibility of the Department of Transportation. We will continue to work with Police Department on this issue until a long term solution for this problem is achieved"



MY PARKING STORY:

A few emails have circulated about the Abandoned Car Law this March. I was once a victim of this law and its abuses. The law states that cars cannot be left "inoperable" on the street or city property for more than 48 hours and the DOT relies on citizens to report abandoned vehicles. The response team is pretty quickthey come out and place a warning on your car that requests you move your vehicle within 24 hours or it will be ticketed/towed. The ticket costs \$152. (which if you think about it, your car is not abandoned if you are retrieving a ticket off of the windshield).

Anyways, my neighbor who did not like that I was parking in a spot next to his house, called 311 and reported my vehicle abandoned. The parking authority placed a warning on my vehicle during a snow storm and the warning was hidden from view under a blanket of snow. Then I received the ticket on top of the snow. I reguested a trial.

Once I requested a trial, I was unable to attend the hearing due to a conflict with work so I petitioned the court (wrote a brief letter requesting a new trial date to District 1 courthouse on Patapsco) and they approved the request but I never received another trial notification. Unaware of the trial date. I missed the trial date again. I petitioned the court again and again I was approved but never received notification. I petitioned the court again and was denied because too much time had passed. So I just petitioned again and I was approved. I was sent a notification of trial and off I went.

3 years after the original date on the ticket. I had my trial and I won because I explained that it had snowed on the date that the warning was issued and the car was never abandoned.
